



# The fear of cowards

Last May 2nd, in an open publication: “Talking about justice in Mexico, it is a country with many grey areas. There are great and brave judges, like Jesús Terríquez and Manuel Bárcena, and some others like Núñez Sandoval, who dishonor the judicial purpose and fall for resolutions full of spite and illegality and get their promotions based in friendship and favors, and off course by running ahead their subordinates’ rights. This man, Luis Núñez Sandoval is a source of shame of the justice he should represent and administrate, he shield himself saying that a senior judicial officer is behind him.”

This citation, is about the fact that while two magistrates, Jesús Terríquez and Manuel Bárcena, based in the letter and spirit of the respective law, had gave me a constitutional protection against the last fake accusation concerning to the expired and solved mining trusteeship matter. The other mentioned judge, Núñez Sandoval, successor of Bárcena, rejected the orders of his coworker, saying that he is not Bárcena and that there isn’t any reason why he should think or be like him, which is obviously ridiculous, because it is the same Court, in which they acted, one in a good sense and the other one against the law, that would be Núñez Sandoval.

What the pessimistic Núñez Sandoval said was completely pathetic; it is not about the person in charge, it is about the institution. It would be as if the current president take out the orders of the last governor, saying that he doesn’t think like him, so, he won’t care.

Actually, Núñez Sandoval, was promoted before The Judicial Council by one of the major traffic of

influences firm, the one at the service of Grupo Mexico, integrated by Fernando Gómez Mont, Julio Esponda and Alberto Zínser, besides other less significant, mercenaries lawyers without ethic, like Agustín Acosta Azcón, who uses fake letterheads like the one in Veta de Plata, which have also the evil, corruption and wicked genes, inherited by their parents.

I brought this fact up, because at the time my persecutors reduce their possibilities to act against me in Court, -thanks to the pertinent defense which is taking my case- they make harder their fake accusations, inventing renew arresting warrants which are contradicted with the resolutions that for 11 times, the courts had determined the exculpatory verdict to me, as a Union leader who had acted according with the law and with honesty and clearness at the forefront of the Union. With all this, the sick desires of my enemies get thwarted, and the moment to come back to México closer. This is the impulse of their cowardice and fear. They know that if I come back to Mexico, with all the safety and protection assurance, all this 7 years of pursuit will be nothing, and everything will be a futile effort, and I will finally act in pro of democracy and union freedom, for my partners and the working-class.

That is how Germán Feliciano Larrea, and some other businessmen, desperately and anxiously uses their dummies, like the mentioned firm, to make people think that I still have outstanding issues about the mining trusteeship. They were bothering over and over again, in an obsessive way; with the worn talk about the 55 million dollars diversion, which from the beginning, in 1990, an insolvency judge defined –and

Germán Larrea accept it- that those resources belong to the Mexican Miners Union, which could use those as its wish and judgment. A parallel audit, pointed out that there isn't a diversion, a part of that money is in a frozen account by a decision of the PAN party, but the money is there, another part of the money had been already given to the miners which had the right to get it.

These last days, are full of gossip in relation with my situation, which let totally clear that the haughty and immoral businessmen whom had planned this political pursuit in plot with the PAN government, –bad experiences, that the current government had not to repeat- have fear, rather panic of my return to Mexico. Over all, there is a total cowardly about the fact that they already had lost the fight against me and the Mexican Miners' Union, which actually is stronger and united than ever, notwithstanding the seven years of conflict.

In this resolution, lots of lawyers, judges, magistrates and ministers had played a pivotal and positive roles, to avoid the fact that the corruption and power abuses could be committed, as well as the legal outrage of find the Miners' Union guilty.

That's why I pointed out in the mentioned publication: "The Federal Judicial Council as well as the Supreme Court had made great efforts to accomplish an administration of excellence. There is so much to be done". A guiding principle is to revise cases like Núñez Sandoval's, which damage so hard the Judicial Authority's image, to correct all this from the beginning and get to the bottom of the matter. In this way, all those courteous judges, who are many, and who day by day do their job with vocation, impartiality and respect to the law and honesty will be honored. Amen.
