AN INTERNATIONAL DISGRACE

AN EVENT THAT SERIOUSLY CONTINUES DAMAGING THE IMAGE OF MEXICO ABROAD.

For the first time in the history of Mexico, INTERPOL rejected, last February 26, 2014, a request of INTERPOL Mexico to apply a Red Notice in an official document, (see attachment) which clearly establishes that the Commission for the Control of INTERPOL's Files (CCF) rejected this request for political persecution reasons and because it fails to comply with INTERPOL's rules and regulations.

Before labour secretary Alfonso Navarrete Prida's reiterated statements, in the sense that the administration of President Enrique Peña Nieto is not politically persecuting the leader of the Mexican Miners' Union, Napoleón Gómez Urrutia, but that only a legal pursuit prevails in which they request the leader to appear before a judge, it seems that secretary Navarrete Prida is acting as the country's general attorney and not as labour secretary. The labour secretary forgets the following:

1. In Mexico there is no guarantee or legal certainty of proper implementation of the law. In the case of the mining leader, since the conflict began in 2006 it has been proved in a clear and convincing way that there was no offence to be prosecuted, which is confirmed in official reports of the National Banking and Securities Commission, by the Special Commission of the Chamber of Deputies, and also by the audit made by the prestigious independent consulting firm of Switzerland, Howard Berney. Nevertheless, they have made 11 times the same false accusation for the same reasons during the last 8 years, without basis and violating the Political Constitution of Mexico, since nobody can be charged more than once for the same offence.

- 2. The Attorney General's Office during Enrique Peña Nieto's administration requested in 2013 from INTERPOL to issue a Red Alert against Napoleón Gómez Urrutia, a request that the Commission of Control of INTERPOL's files (CFF) rejected for the first time in Mexico's history, for being based on political persecution and falsified information that the Attorney General's Office used not complying with the rules of INTERPOL.
- 3. Mr. Navarrete has also declared publicly that there are people affected when actually there were only 3 individuals who demanded his participation, and they were expelled since the year 2000 in the Union's National Convention for charges of treason, corruption, and espionage. These individuals had never worked in Cananea or in Nacozari. Their names are Elías "El Sope" Morales, Martin "El Loco" Perales and Miguel "La Perra" Castilleja. These were agents infiltrated in the union by German Feliciano Larrea Mota Velasco and they are the ones who created the letterhead of Veta de Plata, sponsored by the lawyers of Grupo Mexico: Fernando Gomez Mont, Julio Esponda, Alberto Zinser, Augustin Acosta Azcon, among others and German Larrea himself. Napoleón Gómez Urrutia was elected in 2002 as Secretary General of the Mexican Miners' Union, and these 3 individuals had already been expelled since the year 2000 and they do not represent anyone of the 300.000 mexican miners who have never questioned the transparency in which the Miner's Trust was handled.

The question is: Which affected persons is Navarrete referring to?
